

Parish Tax Refund Scheme

Dear Parishioner

I would like to begin this introduction to our parish tax refund scheme by saying a very sincere word of thanks to you for your continued financial support of the parish over the years. Without your support the recent restoration of our parish Church would simply not have been possible.

As you may know like all parishes St. Agatha's falls into the category of a charitable organisation for tax purposes. As such we are entitled to a tax refund on all donations made to the parish i.e. Family Offering, Easter and Christmas Dues.

How does this work?

- Your annual donation needs to be €250 or over -(Family Offering, Easter and Christmas Dues donations).
- This applies to **PAYE Tax Payers only**.
- ◆ A CHY2 Form needs to be completed. The information required on this form is:
 - Your PPS number
 - Rate of tax that you are paying i.e. 20 % or 42%
 - Your signature
- All information is confidential.

These forms will be delivered and returned in a sealed envelope by your collector during the coming week. If you do not receive a form within the next two weeks or have any queries please contact the sacristy at 8554078 or myself at 8556474.
